- 5. Boyd Sartin called for reports from the standing Committees of TexAmericas Center. No Committees had met since the last board meeting.
- 6. A motion was made by Don Morriss and seconded by Justin Powell to approve the items listed under the Consent Agenda. The motion carried unanimously by voice vote. Those items were:

- 8. Steve Mayo gave an update regarding regional water.
- 9. Liz Fazio Hale, Executive Director/CEO Riverbend Water Resources District and Jim Green, Vice-President of the Board of Directors, Riverbend Water Resources District, gave a brief update regarding a current overview of Riverbend Water Resources District and offered to answer questions from the Board and staff.
- 10. Scott Norton presented an update on the I-30 Corridor Working Group.

 - d. Section 551.087 of the Texas Government Code; Deliberation regarding Economic Development Negotiations.
- 13. A motion was made by Gabe Tarr and seconded by Marc Reiter to reconvene in Open Session at 1:37 p.m. The motion carried unanimously by voice vote.
- 14. Considered and took action upon Resolution #20161025-01 authorizing the Executive Director/CEO to enter into a written contract to retain the services of Atchley, Russell, Waldrop & Hlavinka to defend pending litigation. A motion was made by Don Morriss and seconded by Gabe Tarr. Vickie Higgins abstained from the vote; otherwise, the motion carried unanimously by voice vote.
- 15. Considered and took action upon Resolution #20161025-02 authorizing the Executive Director/CEO to execute a lease modification with Expal USA, Inc. for expanded warehouse space at 557 Elm Street, Hooks, TX, upon the TAC-Eastern campus. A motion was made by Gabe Tarr and seconded by Don Morriss. The motion carried unanimously by voice vote.

With no other business to discuss, a motion was made by Marc Reiter and seconded by Don Morriss to adjourn the meeting at 1:39 p.m. The motion carried unanimously by voice vote.
