TERMS AND CONDITIONS:

1. The company listed above is financially responsible for payment.
2. Client agrees to pay all reasonable legal fees, court costs, and collection cost incurred for results of non-payment.
3. **ADDITIONALLY CONTRACTED WORK RIDER:**
This agreement, including any additional work throughout the calendar year may be executed per the clients approval. Service investments may range from \$400 to a maximum of \$9,000 per project. It is expressly understood and agreed that WEDA conducts no additional business without the written and approved consent of the client. No term, provision, or condition of this agreement may be altered, amended, or added except upon the execution of a written agreement by the parties hereto. Any notices provided for herein shall be in writing and shall be emailed or mailed to the client at the addresses provided.
4. TexAmericas Center retains the right to terminate this contract at the expiration of each budget year (September 30 of each year) occurring during the term of this contract. TexAmericas Center executes this contract conditioned on the fact that it shall use its best efforts to obtain and appropriate funds during each budget year for payment of the sums payable by TexAmericas Center under this contract. This contract is a commitment of current revenues only.
5. World Economic Development Alliance agrees to provide the services, access, and internet websites necessary for Company to fully utilize the WEDA Elite Package during the term of the Agreement.
6. This Agreement shall be construed under the laws of the State of Texas without regard to choice of law rules of any jurisdiction. Jurisdiction and venue shall be in the District Court of Bowie County, Texas. If either party retains an attorney to enforce this Agreement, the party prevailing in litigation is entitled to recover its reasonable attorney's fees and court and other costs.
